A PERSONAL WORD FROM THE PASTOR:

Thank you for your interest and willingness to serve our young people at Faith Baptist Church! The following form is required of all potential youth workers, from the nurseries up through the Youth Group. It is not intended to discourage any one from volunteering in these ministries, but is a necessary precaution in light of the great amount of influence our youth workers have in the lives of the young people at Faith Baptist Church.

I Peter 2:11-14 says, "Dearly beloved, I beseech you as strangers and pilgrims, abstain from fleshly lusts, which war against the soul; having your conversation honest among the Gentiles: that whereas they speak against you as evildoers, they may by your good works, which they shall behold, Glorify God in the day of visitation. Submit yourselves to every ordinance of man for the Lord's sake: whether it be to the king, as supreme; or unto governors, as unto them that are sent by him for the punishment of evildoers, and for the praise of them that seek to do well."


From these verses, we learn the principle of striving to keep a testimony that is above reproach for sake of the fact that we represent Christ to the lost. As part of that principle, we are told to "submit to every ordinance of man for the Lord's sake". It is clear from the context, that Peter has legal ordinances in mind. The fact that this form, including the detailed and sensitive information that it involves, is required, is not intended discourage you or your child from working in the ministry at Faith. We are excited to mobilize and encourage any who are willing to serve in the ministry. We do, however, have a responsibility to parents and to the law to inquire as much as we can as to the credibility of those who work with the children at Faith Baptist Church.

I hope that as you read over and fill out this form you will seek to understand the biblical and legal requirements that make it necessary. Please know that this form is entirely confidential. Its contents will be reviewed by one of the pastoral staff, and then it will be filed away securely.

In keeping with the principles taught in Matthew 18:15-17, you will be approached personally with any concerns or accusations that may involve you.
